The following applications are on display to the public in the Committee Room starting Monday 15th February until Friday 5th March.

Mon Plaisir Stores – replacement storage shed at rear of store.
rear of Dixcart Cottage – relocation of electricity sub-station.
rear of Power Station – storage shelter to protect equipment.

La Seigneurie – new boiler house and replacement of two dormer windows with skylights.

Dixcart Hotel – minor modifications to the glazed link between the existing and new elements of the hotel.

Dixcart Hotel – increased depth to the copper roofed glazed link along the back of the existing hotel.

Dixcart Hotel - conversion of an existing window into a door on the south wing of the existing hotel.

Dixcart Hotel – courtyard canopy replaced with new columns and slated roof.

Dixcart Hotel – increase in size of the first floor bedroom windows of the new bedroom block.

La Jaspellerie House – replacement of slate roofs to the ground floor accommodation with traditional sheet copper roofing to create a considerably lower roof pitch thus reducing the height and massing of the roof profile.

La Jaspellerie House – new granite columns as an entrance portico on the north elevation.

La Jaspellerie House – replacement of the east elevation kitchen window with a pair of patio doors.

La Moinerie Hotel – the relocation of Units 9 & 10 to a previously unused overgrown scrub area behind the grassed sitting area to save cutting down long established trees; to introduce indigenous trees on the previous plot.

Rang's Jewellers – proposed shed.

Rang's Jewellers – alterations to window and door on existing structure.

Bel Air Inn – new external doorway – reinstatement of an original doorway in place of an existing window.

Food Stop – rear extension to retail outlet.
