- Maison Lafayette** – change of some windows and a door; change of use of part of the building  
**Nicolles' Restaurant** – storage shed (3.66m x 1.52m x 2.13m max high [5.56m<sup>2</sup>])  
**La Vaurocque** – horse “house” & store for associated equipment (9.79m x 9.79m x 4.57m to ridge [95.84m<sup>2</sup>])  
**Romarin** – sun lounge converted to greenhouse  
**Hathaway's Restaurant** – new toilet block accessed directly from restaurant area  
**Demi de Balme** – change of outside specification using different materials  
**Millennium Field** - extension to the existing storage shed (6m x 3.65m x 3.20m to ridge [33.36m<sup>2</sup>])

**La Varocque** – widen gateway (3.05m to 3.35m) - **APPROVED**

**The Gallery Stores** – replacement of three pane bedroom window with four panes – **APPROVED**
