MINUTES of the CHRISTMAS MEETING of CHIEF PLEAS

Held in The Assembly Room, Sark on 21st JANUARY 2009 at 10.00 am.

Present: Sieur J.M. Beaumont OBE, Seigneur; Lt.Col. R.J. Guille MBE, Seneschal; A.W.J. Adams, Prévôt; T.J. Hamon, Greffier; Mrs. W. Kiernan, Treasurer; and the Constables. His Excellency the Lieutenant Governor, Vice-Admiral Sir Fabian Malbon, KBE, also attended.

28 Conseillers were present at the roll call (see attached list).

Opening Remarks

- (a) The Seneschal welcomed His Excellency the Lieutenant Governor, Lady Malbon, Lord and Lady De SaumArez and Col. Richard Graham MBE, ADC to HM Governor, to this the first business meeting of the newly constituted Chief Pleas.
- (b) The Lieutenant Governor spoke to the Assembly, saying that he hadn't expected to be part of history when he had taken his appointment; today was a historic day and he drew parallels to the inauguration of President Obama in the United States the previous day. He recognised the struggle it had been to achieve the real democracy that is being seen for the first time today and he congratulated all those who had brought it to fruition. There could still be difficult times ahead but he was confident that Chief Pleas would overcome those obstacles just as others had overcome problems throughout the Island's history.

He was heartened by the good wishes sent to the Island by Guernsey, Alderney and Jersey.

Her Majesty the Queen continues to show a keen interest on matters concerning Sark and is well informed of progress. He gave Chief Pleas and the Island his best wishes for the future.

- 1.7 Williams P. <u>Item 23 (Road maintenance)</u> gave an update on the use of the Meri-crusher and grader used on the Island's roads with work starting on Friday 9th January and continuing every day, including Sunday, until Thursday the 15th; six days in all. The roads treated were
 - o Harbour Hill, from the end of the Bituchem section to the top;
 - The Avenue;
 - The bump at the back of The Gallery;
 - The War Memorial around the corner towards Clos de la Tour;
 - All Rue Lucas;
 - Clos a Jaôn to Carrefour;
 - The entrance to Nightingales stables to Adrian Guille's House;
 - The Heart to La Seigneurie Farm gate;
 - The Old Pavilion to Plaisance;
 - Creux Tunnel;

And three private jobs -

- The lane to Stocks and Dixcart Hotels;
- o The lane down past the Vallette:
- The lane at Mon Plaisir.

The weather was very kind and many things have been learnt. Time will tell as to how well the experiment has gone and he stressed, very strongly, that the whole exercise had been an experiment. He was aware that some of the roads are flat and aware of the mud; knowing the locations, efforts will be made to resolve any problems this winter.

1.9 Williams P. The grader that came with the Meri-crusher was an unknown quantity and the team was unsure how much camber it would be getting. He accepted this was not entirely successful but, if the Meri-crusher returns in future, then different levelling equipment will be used. Soilband has been used on most of the Rue Lucas but this product can take up to 28 days to cure so results are unclear.

He asked that thanks be recorded to -

- Reeds who only charged when the Meri-crusher was operating; normally their charge is £500 per day once the machinery leaves their works until its return;
- Soilbind for reducing the price of a barrel of the compound from £1,050 to £695.
- Sark Estate Management (SEM) due to the logistical problems for Sark Shipping of unloading the machine safely in Sark, SEM was approached and agreed to transport the oversize machine on the Brecqhou Warrior. This enabled the machine to be driven straight off onto Creux Harbour beach and up the slipway. Following a further request, the return journey was also so arranged. Some fairly urgent work on the Brecqhou Warrior was put on hold as a result.
 - As a gesture of goodwill no charge has been levied to Sark in respect of using the vessel, the services of the crew, or the insurance costs. Conseiller Williams couldn't thank SEM enough for the prompt and professional approach;
- Antony Dunks, Jim Pollard and Adrian Webber who worked alongside him for the whole six days without grouse or grumble.

1.11 Williams P.

<u>Item 27 (Conversion to Organic Farming)</u> – read out an e-mail received from an organic farmer in the UK –

It sounds a great idea in principle Sark going organic but very complicated to implement. Firstly, which symbol would you use – a European one or one of the two English ones? We have the Soil Association and Organic Farmers and Growers. The latter has less stringent rules in, for example, animal welfare.

Secondly, how would this be policed? We had an annual inspection in which our land, buildings, accounts etc., in fact everything was checked. If all was okay we were allowed to use the symbol for the next year. So will each of the businesses on the Island be checked separately and if so what happens if one fails? When you say island-wide does this just mean agricultural land or all of the island's gardens, roadsides, footpaths etc. If it is the latter then I can't see how it could be enforced.

If it is the former you still have the problems of spraying going on right next to an organic field especially on a windy site which you definitely are.

Conversion usually takes two years before you can use the organic symbol.

The other main problem is cost. If you use a recognised symbol then the annual inspections are going to cost a great deal. It cost us several hundred pounds for one small market garden and the inspector came from down the road.

3.1 Dewe R. The new Committee has adopted the report written by its predecessor. It is legislation to combat money-laundering and terrorism and needs to be passed ahead of the IMF inspection; this has now been delayed to late 2009 or even 2010, those carrying out the inspection having been diverted to other work during the International financial crisis. 3.2 Gomoll Investigated yesterday what Sark businesses would be involved with this legislation. His company, SG Law, seems to be the only business affected on Sark. To that end he declared an interest. Neither of the two Sark Estate Agents is registered. If they want to register in future, this Law would make it more difficult for them to do so. 3.3 Cocksedge In the days when Jonathan Brannan (former Tenant on Chief Pleas) was involved, meetings were held with the Commission. Does this still happen? Dewe R 34 Representatives of the Guernsey Financial Service Commission (GFSC) meet as required with the GP&A Cttee, the most recent meeting was last year (5th November 2008). 3.5 Henry Sark Estate Agents were both consulted and invited to comment on the new legislation

Each may have made a conscious decision not to apply for registration.

- 3.7 Cocksedge In Clause 8 (4)(c), reference is made to a Juge Délégué; can someone explain the term?
- 3.8 Gomoll It means a judge stand-in.
- 3.9 Cocksedge If a Court is held here, where will any fines levied go?
- 3.10 Seneschal Need to ask GP&A Committee.
- 3.11 Gomoll Referred to Clause 27 - Without prejudice to any jurisdiction exercisable apart from this section, proceedings for an offence under this Law may be taken, and the offence may

for all incidental purposes be treated as having been committed, in any place in the Bailiwick. Practically that means that it could be heard in Guernsey. He assumed that clause was there for the convenience of GFSC to prescribe where any court

proceedings take place.

- 3.12 Seneschal Were these issues raised in consultation?
- 3.13 Gomoll Pressure was put on the GP&A Committee to pass this legislation because of the

imminent visit of the IMF early in 2009.

There could now be time to take these matters up.

Proposition - CARRIED

Education Committee Report with Proposition

Headteacher attending Committee

4.1 Magell

The Education Committee has brought this proposition to the new Chief Pleas as soon as possible because the old committee were unanimous in believing it to be of the utmost importance and the new Committee also agree. It is obvious to us that the Headteacher's direct involvement with this Committee is vital.

It would be madness to have meetings and discussions about the management of the school without the Headteacher. You would then have to meet with the Headteacher to discuss what has been discussed at the meeting and then meet with the Committee again after that to discuss what has been discussed with him or her. Utterley ridiculous! Conseiller Magell realised that the Committee is a bit teacher heavy at this particular point in its history but this is very unusual and a few years ago there was no one with any relevant educational experience on the Committee and in the future this may again be the case from time to time.

The Education Committee has brought this proposition to Chief Pleas before and lost due to the view being taken that it would be awkward to have a meeting to discuss issues to do with the Headteacher's position or performance. In practice, this is not awkward because we all know that sometimes there are issues that we have needed to discuss in private. On these occasions we have asked the Headteacher to leave the meeting.

This is why we would like to slightly change the wording of our proposition to replace rest with majority so that procedures are clear from the outset.

The Committee therefore bring this proposition back now to the new and hopefully more enlightened and forward thinking Chief Pleas and Conseiller Magell urged a vote in favour of the proposition.

- Cocksedge 4.2 Supported the proposition but asked was there an independent procedure for teachers?
- 4.3 Magell There is a complaints procedure for both parents and teachers.
- Cocksedge There should be an independent appeals procedure.

Proposition - CARRIED

That the Headteacher of Sark School, or, at times when there is no Headteacher, the Acting or Deputy Headteacher, should become an ex-officio member of the Education Committee with immediate effect.

Isle of Sark Shipping Company (IoSS)

9.1 Cole This report has been inherited from the previous Committee, it having been written following meetings between the Committee and the new Directors. Since its writing there has been a well attended Public Meeting and the Directors have had more time to

familiarise themselves with the Company and its operations.

The new Committee has considered this report and its propositions and felt it necessary to make some changes. A new set of propositions has been printed in full and these will now be issued and Members will be able to see the changes made.

It is intended to go through an explanation and invite questions before each proposition is considered and voted on. The new Committee will do its best to answer them; he asked if there were any general questions but none were forthcoming.

A new set of propositions was distributed and the Seneschal allowed a five minute cessation of proceedings for Members to read and compare the changes.

Proposition 1 is not a generalised expression of goodwill. It is important the Directors of loSS have the full support of Chief Pleas. It also emphasises that Chief Pleas is retaining

control of its lifeline shipping service. It is hoped that when restructuring has been completed in the medium term, the Company will become self funding.

The Directors have been very open with their findings so far and shared this information at the Public Meeting. They are investigating every detail of IoSS operations. Neither Robert Taylour nor Julie Mann are shrinking from confronting the problems or upsetting

long held practises which are of no benefit to the Company.

- Funding of the Company is a key issue and the Shipping Committee has met with the Finance and Commerce Committee (F&CC) four times in the last five days. If the Chancellor of the Exchequer had to deal with our F&CC there would be no financial crisis in the UK. They are a tough bunch of women with a couple of token blokes in support. The Shipping Committee is not supporting every request from IoSS for money at this stage. Every request must be filtered through Shipping & F&CC in future.
- 9.6 Gomoll Checked that this was not a "letter of comfort" to be relied on by a Bank without going back to Chief Pleas and this was confirmed by Conseiller Cole.

Proposition 1 - CARRIED

That Chief Pleas continues to support the Isle of Sark Shipping Company for the foreseeable future.

9.7	Cole	The second proposition has changed; the numbers have gone down – surprise.
		Consultation with the F&CC was imperative to see what was affordable now. The revised figures are fully supported by the F&CC.
9.8	Atkinson	Confirmed that the financial revisions now incorporated into Propositions 2 & 3 are supported and endorsed by the Finance and Commerce Committee.
9.9	Cole	By capitalising the present loans, these become an investment for Chief Pleas. The outstanding loan will remain and be guaranteed for 24 months during which time it will be
		reviewed. This arrangement gives IoSS security in the meantime.
9.10	Bateson	Asked for clarification of the advantage to the Company
9.11	Cole	The £335k no longer shows as a debt and puts the Company on a sounder financial footing. The arrangement doesn't actually cost Chief Pleas anything.
9.12	Melling	, , , , , , , , , , , , , , , , , , , ,
	J	Asked if the remaining loan would be interest free.
9.13	Cole	Confirmed it would be.
9.14	Bateson	Is there not some inconsistency here by strengthening the balance sheet but devaluing the ships?
9.15	Cole	The re-evaluation of the ships is an ongoing discussion. There are various ways of

valuing the ships and these alternatives need to be considered.

Proposition 2 - CARRIED

That Chief Pleas agrees the capitalisation of the two earliest of the Chief Pleas' loans, of £75k and £260k, totalling £335k, into shareholder funds; and leaving the remaining £304k as a loan which will not be recalled for 24 months while it remains as a loan.

9.16	Cole	Proposition 3 removes the reference to further advances in 2010 and 2011. The Committees are waiting on more and better information being available. The £200k loan advance for 2009 will be treated in the same way as the existing outstanding loan.
9.17	Henry	Have the Directors been involved in the discussions between Shipping and F&CC?
9.18	Cole	Confirmed they had been fully involved in the negotiations and are satisfied with the arrangement currently proposed.
9.19	Melling	Is this additional loan also interest free?
9.20	Cole	Confirmed that was so.

Proposition 3 – CARRIED

That Chief Pleas makes available additional funds of up to £200k during 2009, on the same terms as the existing loan of £304k referred to in Proposition 2 above.

9.21 Cole It was essential to let IoSS continue running.

Proposition 4 refers to the Spencer Report which was produced at the end of December 2007. This Review had as its main recommendations –

- Financial Restructuring of loSS this is now underway;
- Full Review of the 1951 (Sark & Alderney) Law the Law Officer allocated to drafting this legislation, having had discussions with the previous Committee, has been diverted to IMF issues. The new Committee will now press for drafting to resume.
- A new long-term service level agreement between loSS and Chief Pleas it is hoped to bring this to Easter Chief Pleas.
- Review of the structure of the relationship between Chief Pleas, its Committees and loSS – previously some of the Directors were Members of Chief Pleas; this is no longer the case and a new relationship has to be defined.

9.22 Seneschal There is no change here from the previous Proposition 4.

Proposition 4 – CARRIED

That Chief Pleas supports the Company implementing the recommendations of Dr. J. Spencer as set out in his December 2007 "Review of Shipping between Guernsey and Sark".

9.23	Cole	Proposition 5 deals with fares; if IoSS is to be viable it has to generate income. Next
		year's estimate of users has been set at 40,000 and all fares are geared to generating
		income from that number. This maybe a pessimistic forecast but with the uncertainties of
		the economic downturn a safer option than building on the 47,000 during 2008.
9.24		The income is based on these predictions so if Chief Pleas asks for a £1 reduction on the
		fare, income would reduce by £40k; if a £2 reduction was required, income would go

down by £80k and so on. The Committee's recommendation is to leave the setting of fares to the Directors. The Directors, in discussion with the Committee and following the public meeting, have agreed a reduction to the standard return fare from £25.99 to £25.50 from 1st February.

9.25 Hunt What is the age range for child fares?

Williams S. 9.26 Infants under 4 go free; children's fares relate to those under 16.

9 27 Prevel In the new fare structure, a reduced fare has been introduced for families. Has some similar reduction been considered for Senior Citizens? It would encourage more to make the trip to Sark. The Early Bird Reduction, using the 8.00am boat is too early for most

Senior Citizens.

9.28 Williams S. Had received representations about the rise in student fares for Sark students going to

College in Guernsey. Currently the five students receive a discount and only pay £15 per return journey reducing the fare from £17.50; the new fare, even with a 15% discount,

will rise to £21.70.

Could the Education Committee consider subsidising these increases?

Perrée 9 29 Although the Early Bird fare is reduced, could it be reduced further to encourage regular

day trippers from Guernsey; reduction would mean they have enough money left to

spend during their longer stay on the Island.

9.30 Cole These are all good ideas that will be passed on to IoSS and followed up in future

discussions.

Proposition 5 – CARRIED

That Chief Pleas approves the changes to passenger fares, *as amended and cargo rates as outline in Appendices 4 & 5 of the Directors' Report.

(* Standard Return Fare is amended to £25.50 from £25.99)

9.31 Cole Was originally confused by this proposition as the loSS 2007 accounts were signed at the shareholders meeting. He suggested a change in the wording to remove confirms the

signing and replaces it with approves.

9.32 Baker F Wished to complement everyone in preparing the Directors Report and the supporting paperwork which was clear and understandable.

<u>Proposition 6</u> – **CARRIED** as amended in the meeting.

The letter of support from HM Comptroller in Guernsey is attached to the report. This Law introduced the concept of staggered elections with fourteen of the elected Conseillers serving for only two years. Thereon after fourteen Conseillers will be elected every two years, thus retaining some consistency and continuity for Chief Pleas, lost by the removal of the Tenants.

Chief Pleas can only annul this legislation should it so wish.

No motion was made to annul "The Reform (Election of Conseillers)(Dates)(Sark) No.2 Ordinance".

17.1	Dewe R.	This is a joint report put together by the GP&A Committee and the outgoing Reform

17.2 Guy Because she was certain that the vast majority of the House would wish to show its support for the role of the Seneschal in the meantime and, for the avoidance of doubt, she asked that GP&A consider amending its proposition to add the following sentence after the word *course* –

"Chief Pleas has complete confidence in the Seneschal continuing in his traditional role until this issue is resolved".

- 17.3 Dewe R. The GP&A Committee is quite prepared to accept this amendment to the proposition.
- 17.4 Plummer Thanked the Seneschal for the role he has played and the support he continues to give especially to the new Conseillers. This was followed by a round of applause.
- 17.5 Baker E. Asked for a named vote and this was supported.
- Was concerned that the GP&A Committee should remain neutral over the new amendment as it was the same Committee tasked with carrying out the investigation.
- 17.7 Guy Had thought carefully about the wording and didn't think it compromised the GP&A Committee. She suggested that GP&A Members could abstain in a named vote.
- 17.8 Seneschal Suggested that Members of GP&A and any Conseillers formerly on ReLEC should retire to consider making it two separate propositions.

Those involved retired from the room to discuss and returned with a decision.

17.9 Dewe R. There was no objection to Chief Pleas expressing its view and splitting the proposition in two; this would allow GP&A Committee to follow its conscience.

Proposition 1 - CARRIED on a named vote - 28 Pour

That Chief Pleas direct the General Purposes and Advisory Committee to consider a plan of action to examine the Dual Role of the Seneschal and report back to Chief Pleas in due course.

Proposition 2 – CARRIED on a named vote – 21 Pour and 7 No votes

That Chief Pleas has complete confidence in the Seneschal in his traditional role until this issue is resolved.

17.10 Seneschal Reminded Conseillers that only Committees can bring propositions from the floor. Please advise Committees ahead of a meeting if changes to propositions are required.

- 18.6 Baker E. It should be noted that it is not the Committee who have selected and put forward these nominations; both requests have been forwarded from the Tribunal Members.
- 18.7 Seneschal Confirmed that the Committees act as a conduit to Chief Pleas for the Tribunals.
