MODIFICATIONS TO TAX PAYMENTS (2014 ONLY)

This report is brought as a result of decisions taken at an Extraordinary Meeting of the Finance and Commerce Committee on 6th January 2014. The meeting was called in response to an email from the SAFE (Sark Action for Families and Employment) Steering Committee raising their concern at the difficulties some individuals, they come into contact with, have in paying their personal and property tax during the winter months of this year. Although on further communication with SAFE no actual numbers of individuals could be provided to support their assertion, the F&C Committee decided to look at the issue. The purpose of this was to see if any changes could be made to the payment schedule that would assist individuals in meeting their tax liabilities, without compromising the cash flow of the government.

F&C concluded that some modifications could be implemented within the law; this was confirmed by the Law Officers of the Crown and applied to the option of a schedule of 9 monthly payments. The committee agreed the following principles;

- Everyone must get their declaration in on time (by 28th January 2014) or a penalty will be applied by the tax assessor as per the current system
- Every person liable to pay tax (who chooses to pay in 9 instalments) must pay something toward their bill on each of the 9 instalment dates starting in January 2014
- The minimum payment per month is £20/person
- Where individuals have arranged with the Treasurer to make the minimum payment of £20/person/month) for the first three months (either monthly or more frequently) on months four, five and six and seven the payments need to increase to cover the shortfall, so that at the end of month seven (i.e. by 28th July 2014) the payments are up to date
- All tax being paid by monthly instalments must be paid no later than 28th September 2014
- Payments can be more frequent than monthly for the first 6 months
- If an individual misses any payment then they will become liable to pay the full amount as per the current rules
- Any agreement reached between the individual and the Treasurer on behalf of F&CC must be set out in writing and signed by the tax payer
- Usual arrangements for paying quarterly and in one single instalment to remain unchanged

That Chief Pleas approves the modifications to tax payments listed above for 2014 only.
