3. Electricity Issues – Policy & Finance Committee Report considered – Propositions carried

To consider a Report with Propositions from the Policy & Finance Committee entitled 'Electricity Issues'.

Proposition 1:

That Chief Pleas instructs the Policy & Finance Committee to engage reporting accountants and specialist valuers to conduct due diligence on Sark Electricity Holdings Limited and its

subsidiary company and/or any other relevant person with a view to a negotiation for the acquisition of the company and/or any assets which are needed to ensure continuity of the supply of electricity to the people of Sark. The due diligence to include the preparation of a current statement of affairs including the up to date valuation of all assets and details of all outstanding liabilities including those relating to any pension fund.

Proposition 2:

That the Policy & Finance Committee reports back to Chief Pleas at as early a date as possible but no later than the Easter Meeting 2019, with a recommendation that, following agreement with the shareholders of Sark Electricity Holdings Limited and/or any other relevant person, a purchase of the Company and/or any assets as described in Proposition 1 should be made by Chief Pleas.

Proposition 3:

That the Policy & Finance Committee, in due course, confirm to Chief Pleas the details of the financial arrangements necessary to enable the purchase to be completed.

The Speaker: In that case we go straight to Agenda Item 3. For those members of the public who want copies, there are copies available, and it will also be on the website, hopefully within the next hour or so.

Agenda Item 3, to consider a Report with Propositions from the Policy & Finance Committee entitled 'Electricity Issues'.

Conseiller William Raymond ... Sorry, Conseiller Reg Guille.

Conseiller Guille MBE: I have been given the one point, sir, but if I can cast it across to Conseiller Raymond ...

The Speaker: We will put you in charge of the bouncing ball, if you like! Conseiller William Raymond.

Conseiller Raymond: Is this where we ... [Inaudible]? (Laughter)

Following the statement by the Director of Sark Electricity that he intends to terminate the electricity supply to the Island from 30th November, much work has been undertaken to deal with the incident this will create. The Island Emergency Services have been working with Bailiwick authorities to plan necessary measures and the Ministry of Justice has been kept informed.

Whilst planning for the effect of the emergency that may be created, negotiations have been continuing to seek an agreed resolution to the potential problem. These negotiations have not been exclusively by Members of Chief Pleas, but have included the Seigneur and the Lieutenant-Governor.

The negotiations have been continuing today, and the latest email from the Director of Sark Electricity was received at 10 minutes past six this evening. We have considered it. We need further information and we will be going back to him in the morning. Unfortunately, it does conclude at the end that the power may still be turned off on 30th November, and I am very sorry that I have to report that, but that is what the email says.

At the root of this problem is the Price Control Order which was issued by the Price Control Commissioner, which is the subject of a legal appeal by Sark Electricity Limited. Chief Pleas as such are not a party to this action. It is very important that everybody knows that we are bystanders in this, although it is our liability under the law to fund the Commissioner's costs.

SEL has made requests to Chief Pleas to annul the Price Control Order, but there was no proposition brought and that did not take place. It has also requested £250,000 to fund the company appeal, but again, there was no proposition for it.

The court hearing of the appeal is adjourned until 3rd December, which unfortunately is less than three days after the threatened discontinuance of the supply.

The Policy & Finance Committee have considered the possible purchase of the companies, but to date have no financial information on which to base a valuation or indeed to agree a basis for valuation.

The bases upon which the Committee has been able to advise Chief Pleas to proceed are contained in the Propositions and, if passed, would be available to the shareholders of the company to accept as an alternative to discontinuing the supply of electricity. For the benefit of those who have not got copies of the Propositions, I will just read them out. We will be reverting to them with the Director of the company again tomorrow morning.

Proposition 1:

Proposition 3:

That the Policy & Finance Committee, in due course, confirm to Chief Pleas the details of the financial arrangements necessary to enable the purchase to be completed.

Those are Propositions on which we hope that we can debate and then we will receive approval today and they can then be dealt with as part of the negotiations going forward.

The Speaker: Conseiller William Raymond, can I just ask you to clarify this: in Proposition 2, I assume that there was an additional piece of explanation there that is not actually part of the Proposition.

Conseiller Raymond: Can you be more specific?

The Speaker: I have the Proposition in front of me but it does not include your ... certainly no explanation –

Conseiller Raymond: I am sorry. Yes, I added that in. We *hope* to be able to do it by the middle of February.

The Speaker: But does that comprise part of the Proposition?

Conseiller Raymond: No, I am terribly sorry. I was ad-libbing!

The Speaker: I am easily confused!

Right, that is the Item moved. Can I ask if there are any questions from the floor or any debate, if anybody wishes to say anything on what has been said so far?

Conseiller Sandra Williams: I would like to thank Conseiller William Raymond for bringing us up to date with where we are here, but I cannot hide the fact that I am disappointed in what we are reading here this evening. I had hoped and the majority of the Island hoped that they would come here this evening to find out that actually we were not going to have the electric turned off on Friday, and that we were going to find our way forward. I would like to appeal to Sark Electricity Company to give us time to do that and leave our power switched on, please.

Conseiller Raymond: I can only quote from the email which was timed at 10 past six this evening in which the Director says: 'We will continue providing electricity until Friday p.m. to give time for these negotiations to complete. If they complete successfully, we will continue. Otherwise we will stop to enable us to go to court on Monday.'

The Speaker: Thank you. Anybody else?

Conseiller Sebastien Moerman.

Conseiller Moerman: Thank you, sir.

There is a very good song called, *I don't bend*. I would support Proposition 1 because if the professional evaluation on this company was made possible, I would suspect that we will not even have to look at Propositions 2 or 3. So I will support Proposition 1, but I really do not think that buying this company is a solution for the people of Sark.

Thank you.

4. Major Incident Command Structure – Policy & Finance Committee Report considered – Propositions carried

To consider a Report with Propositions from the Policy & Finance Committee entitled 'Major Incident Command Structure'.

Proposition:

That Chief Pleas approve the Command Structure and other measures given in this Report.

The Speaker: We now go to Agenda Item 4, to consider a Report with Propositions from the Policy & Finance Committee entitled 'Major Incident Command Structure'.

Conseiller Reg Guille to introduce this Item.

Conseiller Guille MBE: Thank you.

This Major Incident Command Structure is not new. There has been a Major Incident Command Structure in place in Sark for a least 10 years. Obviously with the threat of a disconnecting of the electricity supply, the Major Incident paperwork/documentation between us and Guernsey was reviewed and there have been some minor changes made to the structure.

Gold Command originally was being convened by the Seneschal, the President and then the Speaker of Chief Pleas. However, we have been advised that it should be a political procedure of command and therefore three Members of Chief Pleas have been nominated to be on that gold Command. They are myself from Policy & Finance; Conseiller Helen Plummer from Medical & Emergency Services; and Conseiller William Raymond, also from Policy & Finance.

The Silver Command (Tactical), as you can see from the report, that is for Mrs A Sturman, Maj. C M Beaumont and K N Adams. We are very fortunate to have Mrs Sturman here with us for this, what we hope will not be a requirement, but she has a vast experience in the Police of operating at very high levels of command. Two of the incidents that she did work on were the *Marchioness* disaster and one of the bombings in London.

So with that Command Structure in place, residents have seen information ... with regard to electricity being switched off. That is a command post will be in the Hall.

Gold Command will have to declare an incident, if the electricity is switched off and then the Civil Emergencies Authority, who have a regulation ready to be implemented, will swing into effect and immediately thereafter the civil contingencies will be put into place on Sark.

I am happy to take questions.

The Speaker: Are there any questions or discussion on Item 4? Nobody is indicating. In that case I will go straight to the Proposition:

That Chief Pleas approve the Command Structure and other measures given in this Report.
