**Le Grand Dixcart** – to erect a greenhouse (12.00m x 4.00 [6.4m] x 4.14m) – **APPROVED**

**La Valette** – to erect a ‘cocoon’ on the campsite (4m x 4m x 2.5m) – **APPROVED**

**Le Fort** – to demolish and old privy and erect a greenhouse/summerhouse – **APPROVED**

**Haut de la Colline** – to erect a sewing room cabin (4.8m x 3m x 2.49m) – **APPROVED**

**Atlantis** – conversion of loft, including raising height of roof ridge by 27” (0.69m) – **DEFERRED**

**Atlantis** – to build a block wall (1.35m) in place of existing plastic fence – **FULL APPROVAL**
